#### IMPORTANT NOTICE

Prior to drafting any contract for goods and services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown below are those we can provide to our clientele. You may choose only those items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery services, flowers, and newspaper notices. The prices for these items will be shown on your bill or statement describing the funeral goods and services you selected. We charge you for our services in buying some of these items.

#### Warranties

Our funeral home makes no representation or warranties about the protective value of certain caskets or outer burial containers other than those made by the manufacturer. The only warranties, expressed or implied, granted in connection with goods sold with this funeral service are the written warranties, if any, extended by the manufacturers thereof. No other warranties and specifically, no warranties of merchantability and fitness for a particular purpose are extended by the seller.

# **Financial Policy**

Payment in full is required 72 hours (3 days) prior to furnishing of any merchandise, ceremonies or disposition. We accept cash, cashier's check, VISA, MasterCard, American Express and incontestable/assignable life insurance policies.

There will be a 7% processing fee on all life insurance policies added to the Cash Advance Section of your Statement of Funeral Goods and Services selected. Any additional cash advance items selected after the Statement of Funeral Goods and Services have been prepared and signed, will be billed to the contracting party, and payment is expected within 30 days. Any outstanding invoices will incur an 18% charge each month it goes unpaid. Sales Tax will be added to the cost of merchandise purchased.

All information given to the funeral counselor at the time funeral arrangements are made must be correct vital information prior to filing with the State of California. It is the contracting party's responsibility to provide the counselor with the correct information. If the information given is incorrect after the filing process has taken place, the death certificate must be amended. This can take several weeks, and you will be responsible for all additional charges incurred to amend and order corrected copies of the death certificate.

### **Timeliness of Arrangements**

Cemeteries require that decisions, financial arrangements and necessary signatures be completed by no later than Noon of the day prior to the intended service/interment. In order to allow sufficient time to finalize the paperwork, an appointment should be made no later than 10:00 am on the day prior to the desired interment. ISOC Mortuary makes no guarantee that we will be able to obtain and file the death certificate in time for an interment the following day.

There is a basic fee that we charge every family for our professional expertise in assisting them with their preferences. It includes a proportionate share of the taxes, licenses, utilities and business expenses required to serve the public. Our charge includes, but is not limited to, consultation with the family, administrative and clerical services, preparation of the death certificate by the attending physician or coroner, necessary permits, filing the death certificates with appropriate agencies, consultation with cemetery or common carrier, assistance with insurance papers, planning the funeral, and placement of obituary notices. There will be a charge for each service requested or required. This fee for our basic services and overheads will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for immediate burials and forwarding or receiving of remains).
